It has become important to us to have in our possession evidence of title to the Unitarian Mission House in Budapest. The instrument which we need is called, "Extract" from the Land Registry."


We have been informed that this Extract might be obtained from the Land Registry office of the District of Pest. I am enclosing material which we have in our files, describing the property, and giving the proper references in the Land Registry office. This information, of course, is for your use.

We have been informed, that an individual, either yourself, or deputy, as a citizen can request this information. In other cases that we know about, the person asking for the certificate has merely stated that he desires, personally, to have information about the real estate.

Will you let us know if there is any charge for this Extract, which we will, of course, be happy to reimburse you for. Also, it will not be necessary to have the document translated, as we would prefer it in the original form.
