Interest is that of owner of an undivided one-third interest in the property above described.

Technical Description

of the Unitarian Mission House of Budapest

Hoyges Endre utca 3.

1./ The building consists of three storeys. Its street length is 20 metres 40 centimetres. Its courtyard length is 34 metres. Number of one-roomed flats: 2. Number of two-roomed flats: 13. Number of three-roomed flats: 8. Apart from the flats this building consists of 1 church, a students home, a clerical office, a students association. There are two staircases, the front staircase and a back staircase. At present the back staircase is out of use, owing to bomb-damage.

The roof is saddle back, covered with tiles. Underneath the building are cellars.

The courtyard is paved with ceramic-stones.

The number of flats, facing the front: 8.

Of these none are one-roomed flats.

Two-roomed flats: 1/one/.

Three-roomed flats: 7/seven/.

All the rest of the flats are courtyard flats.

The courtyard flats are approached from the front staircase by means of corridors, which run right around the building, provided with railings.

At the back of the building there is a courtyard 20 metres 40 centimetres long, 4 metres wide.
